1. It is my responsibility to study and adhere to the requirements of the Teacher Education
Program as detailed in the
<u>Teacher Education Handbook, Student Teaching Handbook</u> , and the <u>Illinois Educator Code of</u>
Ethics including DCFS Mandated Reporter training and acknowledgement.
2. It is my responsibility to understand and be guided by the requirements of the
Illinois Professional Educator Standards (IPES) and the Culturally Responsive
<u>Teaching and Leading Standards</u> (CRTL).
3. My status in the Teacher Education Program will be reviewed each semester. I may be
dropped from the TEP if my cumulative/major GPA falls below 2.75, my professional
education GPA falls below 2.85, if I fail to demonstrate expected professional behavior and
dispositions in the classroom or the field, or other circumstances occur which may
disqualify me from licensure.
4. I must achieve a GPA of 3.0 (cumulative, major, and professional education) by the
end of the semester prior to student teaching to be eligible to student teach.
5. I must consult with my academic advisor(s) each semester to confirm all requirements
have been completed prior to student teaching.
6. I must successfully complete a minimum of 100 field hours prior to student teaching
and submit official field experience logs documenting these hours.
7. I understand that a passing score on a content area exam must be posted in my <u>ELIS</u>
account prior to being licensed. This typically means a passing score on content exam in
major/initial endorsement by April 15th Senior Year and passing scores on all subsequent
endorsement exams by April 15th of Senior Year which means posted on ELIS by April 30th for
spring graduates and Nov. 15th/30th for December graduates. The university study support
for the content exam is only available while the student is on campus.
8. I must meet the criminal background check requirements and health requirements of
the school district of my student teaching placement. I am responsible for any and all
costs associated with these requirements. If I am placed in more than one school
district, I am responsible for the requirements set by each district. I also must
complete the DCFS Mandated Reporter course and provide the certificate and
acknowledgment.
9. I am <u>responsible for transportation and transportation costs</u> to and from my student
teaching and pre-student teaching placements, and I understand that I may be placed
up to <u>60 miles away</u> from Illinois Wesleyan University.
10. I cannot be assigned to a cooperating teacher who is a relative or close friend, nor can I be
placed in a school that I
attended or that family works in. The Director of Field Placement is responsible for the
placement of student teaching.

11. I am responsible for informing the Director of Field Placement, or Head of Music Education, of any issues or concerns that might affect my field placement.
